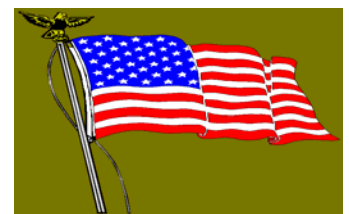

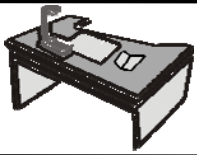
Unit 24 Ladies Auxiliary, FRA President's Message


GOOD OF THE ORDER

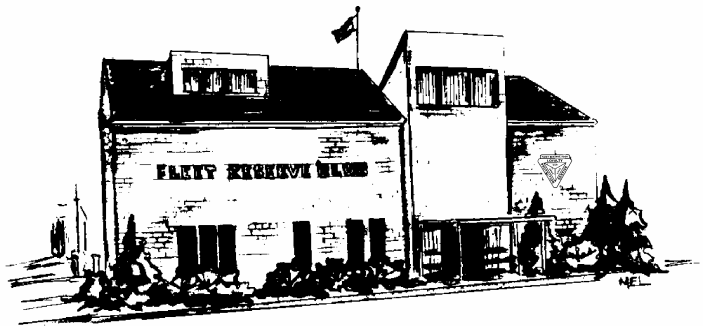
